GENERAL INSTRUCTIONS:

- Full payment of the entire fee is mandatory at the time of admission as per the schedule laid down by the school. Payment of school fee will be accepted by a bank draft or 'at par' cheque. Demand Draft should be made in the name of "St. Vivekanand Public School" payable at Bhind & also can be remitted through online payment facility.
- Transport facility is optional and Transport Fee Charged for 11 Months only.
- All the Payments have to be made by 10th of every quarter.
- If the entire fee of a student deposited at a time of admission, 5% concession will be given in the tuition fee.
- The amount deposited towards registration and admission for a particular year is neither refundable nor transferable to any other year. Fresh registration will be required if the child is to be given admission for a subsequent admission year.
